

# EMPLOYEE BENEFITS HIGHLIGHT SHEET- Evangelical Covenant Church of Canada

(Please refer to the booklet for complete plan details)

## **Eligibility:**

• Employees must work at least 25 hours a week to be eligible under the plan

### **Classes:**

- A Manitoba Employees
- B British Columbia Employees
- C Alberta Employees
- D Ontario Employees
- E Saskatchewan Employees
- F Quebec Employees

### Life Insurance:

- Life benefit equal to 2 x annual earnings up to a maximum of \$1,000,000
- Non-Evidence Maximum Limit \$400,000
- At age 65, the Life benefit will reduce by 50% and terminate at age 70
- Conversion privilege; upon termination of your insurance you have 30 days to convert your Life coverage to an individual policy with no medical questions asked

### Accidental Death & Dismemberment:

Matches Life Insurance Benefit

### **Dependent Life:**

- \$15,000 life benefit in the event of death of a spouse
- \$7,500 life benefit in the event of death of a child
- Conversion privilege; upon termination of your insurance you have 31 days to convert your Dependent Life coverage to an individual policy with no medical questions asked

### Long Term Disability:

- Monthly benefit is 60% of gross earnings non-taxable
- Maximum monthly is \$5,000
- Benefit will commence 112 days after the date of disability
- Benefit duration: 5 years
- Benefit terminates at age 65

#### **Extended Health Care:**

- Ambulance & Semi-Private Hospital reimbursed at 100%
- Prescription Drugs reimbursed at 80%
  - Includes a pay-direct prescription card
- Out of country coverage reimbursed at 100%
  - Be sure to read Manulife's pre-existing condition brochure prior to departure
  - Coverage will not be provided for employees travelling to countries listed on the Government of Canada travel advisory bulletin where travel is not recommended or high-risk
- All other services reimbursed at 100% including:
  - Orthopedic shoes: \$150 per calendar year, Custom-Made Orthotics: \$400 every 3 calendar years
    - Doctor's note is required. Please contact our office for claim submission guidelines
  - Hearing aids: \$500 every 5 calendar years
  - Paramedical Practitioners at \$500, per practitioner per benefit year, including Chiropractor, Osteopath, Podiatrist/Chiropodist, Massage Therapist, Naturopath, Speech Therapist, Physiotherapist, Acupuncturist, Psychologist.
    - *Reimbursement for paramedical practitioners will be based on the reasonable & customary fee guide & province of residence*

### Vision Care:

- One eye exam every 12 month for children
- One eye exam every 24 months for adults

### Dental:

- Basic Services reimbursed at 80% up to \$1,000 calendar maximum (per person)
  - Cleanings, fillings, x-rays, root canals etc.
- 6-month recall exams
- For any work over \$500, we recommend submitting a pre-estimate to Manulife prior to having the work completed
